Summary: Attached is a copy of the annual "Certificate of Highway Mileage" required by the Vermont Agency of Transportation to be completed by 2/20/2024. No changes to the Town's Highway mileage have been made this year.

Town Plan Impact: N/A

Fiscal Impact: The Certificate of Highway Mileage is required for the receipt of approximately \$190,000 of Annual Highway Block Grant funding. The value of the Block Grant is determined based on the number of miles on Class 1, 2 and 3 town highway. No funding is provided for class 4 town highway or legal trail mileage.
