Special Event Permit Application

Summary: The Town of Stowe has received Special Event Permit Applications for the following event. This is a new one-time event.

Trapp Family Lodge Solar Viewing Event: Sunday, April 8, 2024, 10:00am – 3:00pm. This event is sponsored by the Trapp Family Lodge and will take place at the Trapp Family Lodge Concert Meadow. The purpose is to view the total solar eclipse that will take place in April. This is a ticketed event with a maximum attendance of 1,200. Food and drinks will be served inside the Lodge, not outside. There will be limited live music, according to an email (attached) from Bob Schwartz. Overflow parking will be located at the Bierhall, and signage will be placed to prevent parking along public roads. SPD will attempt to provide the signage. Chief Hull has determined that police are not required for this event.
