## Agenda Item No. A-5 Stowe Lower Village Center Renewal Application

**Summary:** The Stowe Lower Village was officially listed as a designated <u>Village Center</u> on April 25, 2016. By statute, the Vermont Downtown Development Board is required to review Village Center Designations every eight (8) years. For Stowe, this review will be in April 2024. To continue participation in this program and receive program benefits, the Town must submit a request for renewal, demonstrating that it continues to meet all of the requirements of designation. Among other items, renewal applications must include meeting minutes, municipal resolution, or signatures of the legislative body showing that the renewal application has been authorized by the municipality.

Village Center Designation supports local revitalization efforts by providing technical assistance and state funding to help designated municipalities build strong communities. Designation offers the following program benefits:

- Downtown and Village Center Tax Credits
- Technical Assistance
- Priority Consideration for State Grants
- Priority Consideration by State Building and General Services (BGS)
- Neighborhood Development Area (NDA) Eligibility


As shown on the enclosed map, Stowe's Lower Village Center encompasses the cluster of historic commercial and residential properties along South Main Street. There are no proposed enlargements or modifications to Stowe's Lower Village Center boundaries being considered at this time as part of the renewal application.

**Town Plan Impact:** Conforms with Stowe Town Plan Economic Development Goal: *To support well-planned and orderly growth and diversification of Stowe's economy in a manner that is compatible with Stowe's identity as a four-season resort community and recreation destination with a traditional New England village.* 

Implements Stowe Town Plan Economic Development Task #3- Continue working with local business and property owners to enhance the economic vitality of the Lower Village Designated Village Center.

**Fiscal Impact:** The renewal application will be prepared by the municipal staff. Continued participation in the program offers various financial and non-financial benefits to both the municipality and private property owners located within the designated village center.

**Recommendation:** Move to approve the enclosed Resolution to submit the renewal application for continued participation in the Vermont Designated Village Center program.
