#### Item A-4 Indigenous Peoples Day Rocks Special Event Permit Amendment

**Summary**: The Town of Stowe has received a request to amend the Special Event Permit Application for the following recurring event:

Indigenous Peoples Day Rocks: Saturday, October 5, 2024 (Rain date October 6), 10:30am – 6:30pm. This is a recurring event hosted by Indigenous Peoples' Day Rocks Foundation. They anticipate attendance of 300+. It will include traditional Indigenous Peoples' celebration including storytelling, preservationists, exhibitors, vendors, artisans and live music. Food vendors will provide hot/cold food and non-alcoholic drinks. Alcohol will not be permitted onsite. Note that organizers have moved this event from Indigenous People's Day weekend to the week before, following discussions with Stowe PD.

The previously approved special event application (2/14/24) had the location as the Mayo Farm Events Fields. After its approval, event organizers determined that it would be more prudent to hold the event at The Current due to the chance of rain. The Current is located inside the Helen Day Arts Center, which also houses the Stowe Free Library. The event will take place both inside the Helen Day Arts Center and on the grounds outside the building. In the event of rain, the entire event will take place indoors. The Current has tentatively agreed to the use of the venue, pending Selectboard approval.

Chief Hull has again determined that police presence is not required for this event, with the stipulation that parking take place at the Memorial Park/Elementary School lot to keep cars off of School Street.



Certificate of Insurance must be filed with the Town at least ten (10) days prior to the event. **Indigenous**
