Agenda Item No. A-3 Stowe Rescue Donation – Patient Transport Equipment (Stair Chair)

Summary: Stowe Rescue, Inc. has offered to donate the cost of a Stryker Patient Transport Equipment for the Town to purchase.

Stryker Manufacturing is the supplier of Stowe EMS' main equipment for moving patients. On each of two ambulances we have a gurney/cot, Power Load mechanism, and stair chair. The cots are where the patient is during care, they are secured to the cot with multiple straps in lieu of seatbelts. The cots are powered by batteries and hydraulics which assist with raising and lowering patients, reducing back strains and lifting stress.

Power Load mechanisms are attached to each ambulance and assist with lifting and supporting the gurney/cot during loading and securing the cot to the patient compartment floor during transport with G-force rated capabilities in case of a motor vehicle accident while transporting. The Power Load mechanisms greatly enhance crew member safety by lowering the potential for lifting/reaching injuries when getting patients in/out of the ambulance.

Stair Chairs are what are used when a patient needs to be moved within a residence/on a scene and the gurney cannot reach the patient due to stairs, narrow corridors, other circumstances. Present stair chairs have a track-like tread mechanism that assists when moving a seated patient down stairs; however, when patients need to ascend stairs, crew members need to lift one stair at a time.

The present stair chairs are 18 years old. Present gurneys are seven and nine years old. Stryker has recently announced that the gurney models we have will be at "end-of-life" and no longer supported for parts/service by the end of 2024/early 2025.

This equipment has been accounted for replacement on a schedule within the EMS budget's Equipment Expense line; however, budgetary pressures during the pandemic, and inflationary pressures greatly increasing the cost of Ambulances has kept the department from replacing this equipment in recent years either per the schedule or when an ambulance is replaced.

Stryker has released a new model of stair chair, the Stryker Expedition. This new model is powered, with this enhancement ease of movement and reduction in lifting is accomplished. The Expedition also climbs stairs which is a significant improvement. In addition to the new model of stair chair, with notification that our present model gurneys are nearing end of life, it is time to replace all.

This purchase will greatly improve safety and comfort for patients and crew members. This purchase will assist in getting to a better position relative to the age of critical equipment and reset the replacement schedule.

Town Plan Impact: N/A

Fiscal Impact: Attached is a quote for replacement of both gurneys and stair chairs. The purchase will be approximately \$80,000.00. The Town's private non-profit partner, Stowe Rescue Squad, Inc., has offered to cover the cost of this purchase in full. Present equipment will be traded-in with credit towards the purchase.

Recommendation: Move to approve purchase of Stryker equipment as specified in the attached quote, and accept the gift from Stowe Rescue Squad, Inc. for reimbursement of the expense.
