The legal voters of the Stowe School District are hereby notified that the Annual Meeting will be held on Tuesday, March 4, 2025, at 8:00 a.m. in the Auditorium at Stowe High School, with voting from the floor on Articles 3-6. The Board of School Directors will hold a public informational hearing on Thursday, February 6, 2025, at 5:30 p.m. in the Music Room at Stowe Elementary School to discuss Article 2.

The legal voters of the Stowe School District are hereby notified and warned to meet in the respective polling places on Tuesday, March 4, 2025, to vote by Australian Ballot on Articles 1-2.

Polling Place and Time

Stowe: Stowe High School Gymnasium, 413 Barrows Road – 7:00 A.M. to 7:00 P.M.

ARTICLE 1: To elect School Directors of the Stowe School District:
a. One for a term of three (3) years
b. One for a term of three (3) years

ARTICLE 2: Shall the voters of the school district approve the school board to expend \$17,762,196, which is the amount the school board has determined to be necessary for the ensuing fiscal year? The Stowe School District estimates that this proposed budget, if approved, will result in per pupil education spending of \$15,454, which is 3.82% higher than per pupil education spending for the current year.

The legal voters of the Stowe School District are further notified that voter qualification, registration, and absentee voting relative to said annual meeting shall be provided in Chapters 43, 51, and 55 of Title 17, Vermont Statutes Annotated.


ARTICLE 3: To elect a Moderator for the Annual Meeting.

ARTICLE 4: Shall the voters of the Stowe School District authorize the School Directors to borrow money to pay current expenses and debts of said District in anticipation of the collection of taxes for such purposes and returns from the State, and, if so, provide that the same be done by notes of the District?


ARTICLE 5: Shall the voters of the Stowe School District authorize the School Directors to apply \$500,000 of the school district's fund balance as revenue for the 2025-2026 school year budget and apply \$766,000 of the district's current general fund balance to the capital reserve fund for future facilities and maintenance needs?


ARTICLE 6: To do any other business that may legally come before the Stowe School District meeting.
